

ORDINANCE 1001-10

AN ORDINANCE ESTABLISHING SPEED  
LIMITS ON A PORTION OF CO. RD. 1000 EAST  
IN DUBOIS COUNTY, INDIANA

WHEREAS, any person operating a motor vehicle on a public highway within Dubois County, Indiana, shall operate the same at a careful and prudent speed not greater than nor less than is reasonable and proper, having due regard to traffic, surface and width of roadway, and to other conditions then existing; but,

WHEREAS, It is the determination of the Board of County Commissioners that limits shall be placed upon the maximum speed which shall be allowed when traveling such public highways; and,

WHEREAS, As a result of study conducted and review made of road conditions at the following location, it has been determined that a more restrictive speed limit is required for the safety of the general public.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF DUBOIS COUNTY, INDIANA, THAT:

1. Motor vehicles operated on Co. Rd. 1000 East from Gramwood Drive to 0.10 miles west of Gramwood Drive being a distance of approximately 0.10 miles, shall be restricted to a maximum speed of 25 miles per hour.
2. Each such public highway shall be posted for such maximum speed limit.
3. Violation of this Ordinance shall be punishable in that manner prescribed by Indiana Statute and by prior Ordinance pertaining to speed limits heretofore adopted by this Board of County Commissioners.
4. This Ordinance shall be effective from and following its passage and proper posting of the described speed limit.




ORDINANCE 2001-11


BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS,  
OF DUBOIS COUNTY, INDIANA, THAT:

1. To prevent damage caused by excess weight on County Roads during periods of freeze and thaw, the Commissioners hereby establish a 10 ton gross load (weight) limit on all motor vehicles operated on County Roads within Dubois County, Indiana during the period from January 15, 2002 through April 15, 2002. Jasper 3<sup>rd</sup>. Avenue from Jasper city limits south to S.R. 162 is exempt from this Ordinance.
2. Operation of a motor vehicle on any County Road in violation of this Ordinance shall be a Class C infraction, as defined by I.C. 34-4-32-4.
3. This Ordinance shall become effective upon publication as required by law.

ORDINANCE NO. 2002-1

AN ORDINANCE OF THE BOARD OF COUNTY COMMISSIONERS OF DUBOIS COUNTY, INDIANA, VACATING A PORTION OF HILL PARK ESTATES AND OF HILL PARK DRIVE IN MARION TOWNSHIP, DUBOIS COUNTY INDIANA

BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF DUBOIS COUNTY, INDIANA, THAT:

Section 1. It is the finding of this Commission, after public hearing, that adequate reason exists for the vacation of Lots 8, 9, 10, 11, 12 and 13 in Hill Park Estates and of that portion of Hill Park Drive located between said Lots in Marion Township, Dubois County, Indiana, which area is described as follows:

Part of the northeast quarter of the southeast quarter of Section 12, Township 1 South, Range 4 West, beginning at the northeast corner of said quarter-quarter section and running thence south 344 feet, south 88 degrees 59 minutes 52 seconds west 466 feet, thence north 342.3 feet to the north quarter-quarter Section line, thence north 88 degrees 59 minutes 52 seconds east 466 feet to the place of beginning and containing 3.67 Acres, more or less.


That proper notice has been given of said hearing; that said roadway has been heretofore dedicated but has never been used as a public highway and that said Lots have never been developed and that no public benefit is to be derived from the continued dedication of said public roadway, or the existence of said Lots; that all Lot owners adjacent to said roadway have petitioned the vacation of said highway; that the vacation of said highway will not diminish the value of any other real estate located in the vicinity thereof; and that no reason exists of the continued existence of said road or platting of said Lots and the same should now be vacated.

Section 2. That said public highway as herein described shall be and is hereby vacated, subject however to a continuing perpetual easement as to any public utility now located within the boundaries thereof; and that portion of the plat of Hill Park Estates containing the above Lots and said vacated road is hereby vacated.



WHEREAS, it is also fitting that we focus on the need for a healing and a reconciliation within our nation;







## ORDINANCE NO. 02-2

AN ORDINANCE OF THE BOARD OF COUNTY COMMISSIONERS OF DUBOIS COUNTY, INDIANA, VACATING A PORTION OF THIRD STREET AND PORTIONS OF CERTAIN ALLEYS IN THE TOWN OF PORTERSVILLE, DUBOIS COUNTY, INDIANA

BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF DUBOIS COUNTY, INDIANA, THAT:

Section 1. It is the finding of this Commission, after public hearing, that adequate reason exists for the vacation of the following public roads and alleys located in Boone Township, of Dubois County, Indiana, to-wit:

Third Street between Lots 107 and 112 together with alleyways bordering Lot No. 107 and Lot No. 112 in the Unincorporated Town of Portersville, Indiana.

That Portion of the common street known as Third Street to be vacated is Sixty (60) feet in width, and runs from the northeast corner of Lot No. 107 and the southeast corner of Lot No. 112 to the northeast corner of Lot No. 106 and the southeast corner of Lot No. 113.

The alleys sought to be vacated are eight (8) feet in width, and are identified as follows:

a. An alley running east to west from the northeast corner of Lot No. 112 and the southeast corner Lot No. 133 to the southeast corner of Lot No. 132 and the northeast corner Lot No. 113, dividing Lot No. 112 and Lot No. 133.

b. An alley running east to west from the southeast corner of Lot No. 107 and the northeast corner of Lot No. 88 to the southeast corner of Lot No. 106 and the northeast corner of Lot No. 89, dividing Lot No. 112 and Lot No. 133.

c. An alley running north to south from the southeast corner of Lot No. 132 and the southwest corner of Lot No. 133 to the northwest corner of Lot No. 88 and the northeast corner of Lot No. 89, dividing Lot No. 112 and Lot No. 113 and dividing Lot No. 106 and 107.

That proper notice has been given by publication and certified mail of said hearing; that the described portions of street and alleys are not developed or used as public ways, no public benefit is to be derived from the continued existence of said public alleys or roadway; that the sole adjacent property owners have petitioned the vacation of said highway and alleys; that the vacation of said highway and alleys will not diminish the value of any other real estate located in the vicinity thereof; that public utilities known to exist within said easement shall remain in place; and that no reason exists for the continued existence of said highway and alleys and the same should now be vacated.





WHEREAS, the Board of Commissioners of Dubois County, Indiana, after a traffic investigation, and having the jurisdiction and responsibility to establish rules and regulations for the operation of vehicles and traffic on the following highways in said County, and;


WHEREAS, the Board of Commissioners now find that it is in the best interests of the citizens of said County to establish rules and regulations for the operation of vehicles in the use of the streets and highways hereinafter designated.


NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF

1. The provisions of this ordinance relate to the exclusion of semi-truck traffic on certain highways in St. Marks, Jackson Township, Dubois County, Indiana.
2. That no semi-truck traffic will be allowed on Co. Rd. 450 East from St. Anthony Road South to State Road 64.
3. That no semi-truck traffic will be allowed on Chestnut Street from 3<sup>rd</sup> Street to Co. Rd. 450 East.
4. Violation of this ordinance shall be punishable in that manner prescribed by Indiana statute and by prior Ordinance heretofore adopted by this Board of County Commissioners.
5. This Ordinance shall be effective from and following its passage and publication and proper signing of the described streets.

## CLICK IT OR TICKET MONTH

**WHEREAS**, saving lives on Indiana's roadways is a priority of this community; and

**WHEREAS**, 894 lives were lost in motor vehicle crashes in 2001 and of this number 70 percent of the victims were not wearing seat belts; and

**WHEREAS**, the Governor's Council on Impaired and Dangerous Driving, a division of the Indiana Criminal Justice Institute, has implemented the Click It or Ticket campaign to increase Indiana's seat belt usage rate; and

**WHEREAS**, "Click It or Ticket" uses high visibility enforcement, aggressive public information and education and intense media coverage to send the message to motorists that if they do not comply with Indiana's seat belt and child restraint laws, they will receive a ticket; and

**WHEREAS**, by implementing the "Click It or Ticket" campaign, WE, along with the Governor's Council, believe that Indiana's seat belt usage rate will continue to increase. We know the single most effective action we can take to save lives on Indiana's roadways is to increase seat belt and child safety seat use. What is important to remember is that if Indiana's seat belt usage rate increases by 10 percent, 100 lives will be saved, thousands of injuries prevented and an economic savings to the state of \$150 million over the next year.

**NOW, THEREFORE**, as the Board of County Commissioners of Dubois County, we do hereby proclaim May, 2002 as **Click It or Ticket Month** for the County of Dubois.

ORDINANCE #02-04

AN ORDINANCE ESTABLISHING RESTRICTIONS REGARDING CONSTRUCTION OR PLACEMENT OF STRUCTURES, IMPROVEMENTS, BARRIER ON PUBLIC HIGHWAY RIGHT OF WAY

WHEREAS, Public Highways are dedicated, developed and maintained to promote the unrestricted travel and use of the public; and,

WHEREAS, It is in the best interest of public safety that highway right-of-ways should be reasonably free of obstructions, surface waters and hazards which constitute a danger to highway traffic.

NOW, THEREFORE, BE IT ORDAINED, BY THE BOARD OF COUNTY COMMISSIONERS OF DUBOIS COUNTY, INDIANA, THAT:

Section 1. No person shall construct, build, establish, alter, install, place or cause to be constructed, built, established, altered, installed or placed on the right-of-way of a public street, highway or roadway or the area dedicated for public street, highway or roadway any trench, structure, barrier, improvement, pipe, conduit, culvert, ground surface alteration or other alteration of existing conditions without first having obtained a permit therefore from the Supervisor of the Dubois County Highway Department.

Section 2. The County Highway Supervisor shall from time to time prepare and submit to the Board of County Commissioners policies, requirements, regulations and specifications which shall be applicable to projects on public right-of-way for which permits are required. Following adoption of such policies, requirements, regulations and specifications by the Board of County Commissioners, the Highway Department Supervisor shall issue permits upon filing of application supported by documentation that a proposed project will comply with such adopted policies, requirements, regulations and specifications, and such bond as the Supervisor determines to be necessary. No project shall be so constructed, altered or repaired as to prevent free and unobstructed passage over, on or across said right-of-way in a safe manner or in such a way as to interfere with the proper drainage and safeguarding thereof.

Section 3. Any trench, structure, barrier, improvement, pipe, conduit, culvert, ground surface alteration or other alteration of existing right-of-way condition performed, constructed, or installed, under permit issued hereunder shall be subject to removal by the County Highway Department, after written notice and without compensation, in the event

that the County Highway Supervisor should determine that such removal is required for public safety, does not comply with the application, or is necessary to perform highway improvement or repair.

Section 4. The County Highway Supervisor may from time to time inspect or cause to be inspected any work performed on County right-of-way to see to the enforcement of the provisions of this Ordinance. Notice shall be given to said Supervisor prior to such work as to the date and time when work will be performed and when filling or refilling of any trench, cut, excavation or ditch will occur.

Section 5. Any construction, trench, structure, barrier, improvement, pipe, conduit, culvert, ground surface alteration or alteration of existing condition upon public or dedicated street, highway or roadway right-of-way in violation of the provisions of this Ordinance is hereby declared to be a public nuisance and shall be abated in the same manner as other nuisances under statutes, regulations and/or Ordinances of the State of Indiana and Dubois County, Indiana.

Section 6. Any person violating any provision of this Ordinance shall, upon conviction thereof, be fined in any sum not to exceed \$500.00. Each separate violation thereof and each day's violation thereof shall constitute a separate offense.

Section 7. If any section, clause, provision or portion of this Ordinance shall be held to be invalid or unconstitutional by any court of competent jurisdiction, such decision shall not affect any other section, clause, provision or portion of this Ordinance.

Section 8. This Ordinance shall take effect from and after its adoption and publication.

ORDINANCE #2002-01

AN ORDINANCE ESTABLISHING FEES FOR DUPLICATIONS OF ACCIDENT AND INCIDENT REPORTS INVESTIGATED BY THE DUBOIS COUNTY SHERIFF'S DEPARTMENT, AND ESTABLISHING AN ACCOUNT FOR THE DISPOSITION OF THE FEES COLLECTED

WHEREAS, The Dubois County Sheriff's Department is required under certain circumstances to provide copies of accident or incident reports to certain members of the public; and

WHEREAS, I.C. 9-29-11-1 provides that the fiscal body of Dubois County shall establish the fee to be collected for such copies.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNTY COUNCIL OF DUBOIS COUNTY, INDIANA, THAT:

Section 1. The Dubois County Sheriff's Department shall charge a fee in the amount of Five Dollars (\$5.00) for each and every accident or incident report copy issued by said Department.

Section 2. Not less frequently than monthly the Dubois County Sheriff's Department shall make a report to the Auditor of Dubois County, Indiana, of all reports furnished during the proceeding month and remit all fees collected to the County Auditor.

Section 3. Upon receipt of the fees, the County Auditor shall issue a quietus for such remittances specifying on such receipt the number of receipts included.

Section 4. Upon receipt of such funds the County Auditor shall deposit such funds to the credit of the Sheriff's accident report account: As provided in I.C. 9-29-11-1 of the Indiana Codes.

Section 5. Upon passage this ordinance will replace Ordinance 84-1, approved on February 21, 1984.

2. Motor vehicles operated on Co. Rd. 325 East from Co. Rd. 300 North to Co. Rd. 300 North being a distance of approximately .25 miles, shall be restricted to a maximum speed of 45 miles per hour.
3. Motor vehicles operated on Co. Rd. 900 South from Co. Rd. 750 West to Pike County Line being a distance of approximately 1.54 miles, shall be restricted to a maximum speed of 45 miles per hour.
4. Motor vehicles operated on Co. Rd. 475 East from S.R. 264 to Convent Road being a distance of approximately 1.05 miles, shall be restricted to a maximum speed of 45 miles per hour.
5. Motor vehicles operated on Co. Rd. 600 North from U.S. 231 to Kellerville Road being a distance of approximately 1.48 miles, shall be restricted to a maximum speed of 45 miles per hour.
6. Motor vehicles operated on Co Rd. 575 East from S.R. 56 to Co. Rd. 900 North being a distance of approximately 2.00 miles, shall be restricted to a maximum speed of 45 miles per hour.
7. Motor vehicles operated on Kyana Road from S.R. 64 to Co. Rd. 625 South being a distance of approximately 1.55 miles, shall be restricted to a maximum speed of 45 miles per hour.
8. Motor vehicles operated on Co. Rd. 900 West from Co. Rd. 150 North to Pike County Line being a distance of approximately 0.86 miles, shall be restricted to a maximum speed of 45 miles per hour.

9. Motor vehicles operated on Co. Rd. 150 South from Old Huntingburg Road to ½ mile west of Old Huntingburg Road being a distance of approximately 0.50 miles, shall be restricted to a maximum speed of 45 miles per hour.
10. Motor vehicles operated on Rustic Acres Road from Schnellville Road to dead end being a distance of approximately 0.23 miles, shall be restricted to a maximum speed of 35 miles per hour.
11. Each such public highway shall be posted for such maximum speed limit.
12. Violation of this Ordinance shall be punishable in that manner prescribed by Indiana Statute and by prior Ordinance pertaining to speed limits heretofore adopted by this Board of County Commissioners.
13. This Ordinance shall be effective from and following its passage and proper posting of the described speed limit.




WHEREAS, the Board of County Commissioners have determined that no through trucks, semitractors, and semitrailers of 10,000 pounds or more shall be allowed when traveling such public highways;

1. Motor vehicles operated on Co. Rd 300 North from 36<sup>th</sup> Street to Co. Rd. 500 West, shall be restricted to no through trucks, semitractors, and semitrailers of 10,000 pounds or more.
2. Motor vehicles operated on 36<sup>th</sup> Street from Jasper City Limits to Co. Rd. 300 North, shall be restricted to no through trucks, semitractors, and semitrailers of 10,000 pounds or more.
3. Motor vehicles operated on Co. Rd. 400 North from 47<sup>th</sup> Street to Co. Rd. 500 West, shall be restricted to no through trucks, semitractors, and semitrailers of 10,000 pounds or more.
4. Motor vehicles operated on 47<sup>th</sup> Street from U.S. 231 to Co. Rd. 400 North, shall be restricted to no through trucks, semitractors, and semitrailers of 10,000 pounds or more.
5. Motor vehicles operated on Co. Rd. 500 West from Co. Rd. 400 North to S.R. 56, shall be restricted to no through trucks, semitractors, and semitrailers of 10,000 pounds or more.
6. Local service traffic shall be exempt from this ordinance.
7. Such public highway shall be posted for such restrictions.
8. Violation of this Ordinance shall be punishable in that manner prescribed by Indiana stature and by prior Ordinance heretofore adopted by this Board of County Commissioners.
9. This Ordinance shall be effective from and following its passage and publication and proper signing of the described roads.

# Proclamation

To All To Whom These Presents May Come, Greetings:

**WHEREAS:** over the past twenty years, medical science has made great strides in learning about substance use and the nature of addiction; and

**WHEREAS:** addiction is a chronic, relapsing illness that involves a number of brain chemistry disorders; and

**WHEREAS:** treatment for addiction is as effective as treatments for other chronic conditions, such as diabetes and high blood pressure; and

**WHEREAS:** substance use and addiction result in huge societal and economic costs, where it was recently estimated that the cost of untreated addiction in the U.S. is \$276 billion a year; and

**WHEREAS:** while the toll that substance abuse takes on family and friends of the individual battling with addictions is immeasurable, hope and recovery are still possible through treatment programs, support programs and counseling; and




WHEREAS, the Board of Commissioners now find that it is in the best interests of the citizens of said County to establish rules and regulations for the operation of vehicles in the use of the streets and highways hereinafter designated.


BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS,

To prevent damage caused by excess weight on County Roads during periods of freeze and thaw, the Commissioners hereby establish a 10 ton gross load (weight) limit on all motor vehicles operated on County Roads within Dubois County, Indiana during the period from January 15, 2003 through April 15, 2003. Jasper 3<sup>rd</sup> Avenue from Jasper city limits south to S.R. 162 is exempt from this Ordinance.
2. Operation of a motor vehicle on any County Road in violation of this Ordinance shall be a Class C infraction, as defined by I.C. 34-4-32-4.
3. This Ordinance shall become effective upon publication as required by law.

ORDINANCE NO. 2002-9

AN ORDINANCE OF THE BOARD OF COUNTY COMMISSIONERS OF DUBOIS COUNTY, INDIANA, VACATING A PORTION OF ABANDONED COUNTY ROAD IN MARION TOWNSHIP, DUBOIS COUNTY INDIANA

BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF DUBOIS COUNTY, INDIANA, THAT:

Section 1. It is the finding of this Commission, after public hearing, that adequate reason exists for the vacation of an abandoned portion of Jasper-Dubois Rd., in Marion Township, Dubois County, Indiana, which area is described as follows:

All that part of the northeast quarter of the southeast quarter of Section 29, Township 1 South, Range 4 West located south of a line beginning at a point on the west line of said quarter-quarter section 30 feet south of the centerline of the Jasper-Dubois Road, as now located, and running thence easterly parallel to and 30 feet south of said centerline for a distance of 334 feet;

That proper notice has been given of said hearing; that said abandoned roadway has been heretofore replaced by a new public highway located to the north of the abandoned section; that the original roadway surface is no longer usable and that no public benefit is to be derived from the continued dedication of said abandoned public roadway; that no owner adjacent to said roadway has reason for use of said abandoned highway; that the vacation of said highway will not diminish the value of any other real estate located in the vicinity thereof; and that no reason exists of the continued existence of said abandoned road and the same should now be vacated.


Section 2. That said abandoned public highway as herein described shall be and is hereby vacated, subject however to a


continuing perpetual easement as to any public utility now located within the boundaries thereof.


