WHEREAS, any person operating a motor vehicle on a public highway within Dubois County, Indiana, shall operate the same at a careful and prudent speed not greater than nor less than is reasonable and proper, having due regard to traffic, surface and width of roadway, and to other conditions then existing; but,

WHEREAS, It is the determination of the Board of County Commissioners that limits shall be placed upon the maximum speed which shall be allowed when traveling such public highways; and,

WHEREAS, As a result of study conducted and review made of road conditions at the following location, it has been determined that a more restrictive speed limit is required for the safety of the general public.


NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF DUBOIS COUNTY, INDIANA, THAT:


1. Motor vehicles operated on Co. Rd. 550 South from State Road 162 to Club Road being a distance of approximately 2.27 miles, shall be restricted to a maximum speed of 45 miles per hour.
2. Motor vehicles operated on Co. Rd. 375 South from Co. Rd. 130 West to Co. Rd. 75 West being a distance of approximately .73 miles, shall be restricted to a maximum speed of 45 miles per hour.
3. Motor vehicles operated on Co. Rd. 75 West from Co. Rd. 350 South to Co. Rd. 375 South being a distance of approximately 0.31 miles, shall be restricted to a maximum speed of 45 miles per hour.
4. Motor vehicles operated on Co. Rd. 350 South from Patoka Road to Co. Rd. 75 West being a distance of approximately .73 miles, shall be restricted to a maximum speed of 45 miles per hour.
5. Motor vehicles operated on Co. Rd. 700 East from Schnellville Road to Co. Rd. 400 South being a distance of approximately 1.36 miles, shall be restricted to a maximum speed of 45 miles per hour.
6. Motor vehicles operated on Santine Road from Hall Creek Road to State Road 164 being a distance of approximately 1.69 miles, shall be restricted to a maximum speed of 45 miles per hour.
7. Motor vehicles operated on Co. Rd. 125 East from Kellerville Road to Co. Rd. 300 North being a distance of approximately 1.48 miles, shall be restricted to a maximum speed of 45 miles per hour.
8. Each such public highway shall be posted for such maximum speed limit.
9. Violation of this Ordinance shall be punishable in that manner prescribed by Indiana Statute and by prior Ordinance pertaining to speed limits heretofore adopted by this Board of County Commissioners.





AN ORDINANCE ESTABLISHING SPEED  
LIMITS ON A PORTION OF CO. RD. 50 EAST,  
CO. RD. 650 SOUTH, CO. RD. 100 WEST,  
HOLLAND ROAD SOUTHWEST IN DUBOIS  
COUNTY, INDIANA

WHEREAS, any person operating a motor vehicle on a public highway within Dubois County, Indiana, shall operate the same at a careful and prudent speed not greater than nor less than is reasonable and proper, having due regard to traffic, surface and width of roadway, and to other conditions then existing; but,

WHEREAS, It is the determination of the Board of County Commissioners that limits shall be placed upon the maximum speed which shall be allowed when traveling such public highways; and,

WHEREAS, As a result of study conducted and review made of road conditions at the following location, it has been determined that a more restrictive speed limit is required for the safety of the general public.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF DUBOIS COUNTY, INDIANA, THAT:

1. Motor vehicles operated on Co. Rd. 50 East from State Road 64 to Co. Rd. 400 South being a distance of approximately 1.54 miles, shall be restricted to a maximum speed of 45 miles per hour.
2. Motor vehicles operated on Co. Rd. 650 South from Club Road to Co. Rd. 500 East being a distance of approximately .84 miles, shall be restricted to a maximum speed of 45 miles per hour.
3. Motor vehicles operated on Co. Rd. 100 West from Ferdinand Road Northwest to 0.60 miles North of Co. Rd. 925 South being a distance of approximately 1.43 miles, shall be restricted to a maximum speed of 45 miles per hour.
4. Motor vehicles operated on Holland Road Southwest from Co. Rd. 720 West to Co. Rd. 1000 South being a distance of approximately 1.29 miles, shall be restricted to a maximum speed of 45 miles per hour.
5. Each such public highway shall be posted for such maximum speed limit.
6. Violation of this Ordinance shall be punishable in that manner prescribed by Indiana Statute and by prior Ordinance pertaining to speed limits heretofore adopted by this Board of County Commissioners.

7. This Ordinance shall be effective from and following its passage and proper posting of the described speed limit.

ORDINANCE NO. 2000-1

AN ORDINANCE TO AMEND THE ORDINANCE (#91-12A)  
TO CREATE AND IMPOSE AN INNKEEPER'S TAX

WHEREAS, The Board of County Commissioners has heretofore established the Dubois County Tourism Commission by Ordinance #91-12; and

WHEREAS, This County Council did subsequently adopt Ordinance #91-12A creating and imposing an Innkeeper's Tax of 3% on gross income derived from lodging income; and,

WHEREAS, It is now desirable to increase the rate of tax imposed on gross income derived from lodging income from 3% to 4%.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNTY COUNCIL OF DUBOIS COUNTY, INDIANA, THAT:

Section 1. County Council Ordinance No. 91-12A, Section 2 is hereby amended to read as follows:

"Section 2. The tax imposed under Section 1 of this Ordinance shall be at the rate of Four percent (4%) on the gross income derived solely from lodging income. This tax shall be in addition to the State gross retail tax imposed by I.C. 6-2.5 on the same income, but shall be imposed and paid in exactly the same manner as the State gross retail tax pursuant to I.C. 6-2.5, but that collection of said Tax and payment thereof shall be made on a monthly basis directly to the Treasurer of Dubois County, Indiana".

Section 2. All other provisions of said Ordinance #91-12A, as amended, are hereby confirmed.

Section 3. This Ordinance shall become effective January 1, 2001.

LIMITS ON A PORTION OF COUNTRYWOOD  
ESTATES ROAD, CO. RD. 445 EAST, CO. RD.  
300 NORTH, CO. RD. 400 SOUTH, CO. RD. 75  
EAST IN DUBOIS COUNTY, INDIANA

WHEREAS, any person operating a motor vehicle on a public highway within Dubois County, Indiana, shall operate the same at a careful and prudent speed not greater than nor less than is reasonable and proper, having due regard to traffic, surface and width of roadway, and to other conditions then existing; but,

WHEREAS, It is the determination of the Board of County Commissioners that limits shall be placed upon the maximum speed which shall be allowed when traveling such public highways; and,

WHEREAS, As a result of study conducted and review made of road conditions at the following location, it has been determined that a more restrictive speed limit is required for the safety of the general public.



1. Motor vehicles operated on Countrywood Estates Road from State Road 162 to Dead End being a distance of approximately 0.50 miles, shall be restricted to a maximum speed of 25 miles per hour.
2. Motor vehicles operated on Co. Rd. 445 East from State Road 56 to Co. Rd. 600 North being a distance of approximately 1.05 miles, shall be restricted to a maximum speed of 45 miles per hour.
3. Motor vehicles operated on Co. Rd. 300 North from Co. Rd. 125 East to Co. Rd. 325 East being a distance of approximately 2.15 miles, shall be restricted to a maximum speed of 45 miles per hour.
4. Motor vehicles operated on Co. Rd. 400 South from Patoka Road to Co. Rd. 75 East being a distance of approximately 0.59 miles, shall be restricted to a maximum speed of 45 miles per hour.
5. Motor vehicles operated on Co. Rd. 75 East from Co. Rd. 400 South to Co. Rd. 350 South being a distance of approximately 0.75 miles, shall be restricted to a maximum speed of 45 miles per hour.
6. Each such public highway shall be posted for such maximum speed limit.
7. Violation of this Ordinance shall be punishable in that manner prescribed by Indiana Statute and by prior Ordinance pertaining to speed limits heretofore adopted by this Board of County Commissioners.

8. This Ordinance shall be effective from and following its passage and proper posting of the described speed limit.

ORDINANCE NO. 2000 - 5AN ORDINANCE OF THE BOARD OF COMMISSIONERS OF DUBOIS COUNTY,  
INDIANA REQUIRING CONNECTION TO SANITARY SEWER SYSTEM.

**Section 1.** Whereas Indiana statute and regulations provide that a governmental unit may require that where a public sanitary sewer system is located within three hundred (300) feet of the property line of any property which produces sewage or similar wastes, a government unit in which said sewer system is located has the authority to require connection to said system and the discontinuance of the use of septic tanks, seepage pit, privy pit and similar structures or private systems (jointly "disposal systems").

**Section 2.** Whereas public health and safety within Dubois County Indiana, makes it necessary that structures within Dubois County cease use of septic tanks and similar disposal systems when a public sewer system is available.

**Section 3.** BE IT ORDAINED that the owner of any real estate within Dubois County, Indiana upon which is located any structure or improvement producing sanitary sewage or waste, and which improvement or any portion thereof is located within three hundred (300) feet of any collection line maintained as part of a public sanitary sewer system, shall disconnect from and discontinue use of any septic tank or similar disposal system and shall connect said improvement(s) to said sanitary sewer system, and shall comply with such service and other regulations as may be from time to time established by the operator of said public sewer system.

**Section 4.** BE IT FURTHER RESOLVED, that notwithstanding the provisions of Section 3 of this Ordinance, any structure or improvement producing sanitary sewage or waste which is served by a septic tank or similar system which system has been installed pursuant to a permit issued by the Dubois County Health Department prior to installation of a public sanitary system described in Section 3 above shall be entitled to continue use of said septic tank or similar system until the earlier of the following events: (1) the passage of seven (7) years from the date of installation of said septic tank or similar disposal system, or (2) the determination by the Dubois County Health Department that said septic tank or similar disposal system has ceased to properly function.

**Section 5.** Connection to a public sewer system and disconnection from a septic tank or similar disposal system, when required under Section 3 above, shall be completed within 45 days following written notice mailed to a real estate owner from the operator of such public sanitary sewer system or from the Dubois County Health Department or from any governmental agency that said public sanitary sewer system is available for use by said owner's real estate improvements. In the event that an owner has delayed connection under Section 4 above, said owner shall connect to the public sewer system and disconnect from the exempted septic tank or similar system on or prior to the end of the exemption period or, in the event of a non-functioning septic tank or similar system, within the period specified in a written notice from the Dubois County Health Department, which specified date shall be not less than fifteen (15) days nor more than forty-five (45) days from the date of said notice.

**Section 6.** This Ordinance shall amend Ordinance No. 1992-6 to the extent that said former Ordinance is in conflict herewith, but said former Ordinance shall remain in full force and effect to the extent not in conflict herewith.

**Section 7.** Any person found to be violating any provision of this Ordinance shall be guilty of a misdemeanor. On conviction, the violator shall be punished for the first offense by a fine of not more than Five Hundred Dollars (\$500.00); for



the second offense by a fine of not more than One Thousand Dollars (\$1,000.00); and for the third and each subsequent offense by a fine of not more than One Thousand Dollars (\$1,000.00) to which may be added imprisonment for any determined period not exceeding ninety (90) days, and each day after the expiration of the time limit for abating insanitary conditions and conditions as ordered by the Health Officer or his agent, shall constitute a distinct and separate offense.

**Section 8.** This ordinance shall be in full force and effect from and after its passage and publication.




ORDINANCE NO. 2000-6

BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS,  
OF DUBOIS COUNTY, INDIANA, THAT:

1. To prevent damage caused by excess weight on County Roads during periods of freeze and thaw, the Commissioners hereby establish a 10 ton gross load (weight) limit on all motor vehicles operated on County Roads within Dubois County, Indiana during the period from January 15, 2001 through April 15, 2001. Jasper Newton Street from Jasper city limits south to S.R. 162 and 3<sup>rd</sup> Avenue from Jasper city limits south to S.R. 162 are exempted from this Ordinance.
2. Operation of a motor vehicle on any County Road in violation of this Ordinance shall be a Class C infraction, as defined by I.C. 34-4-32-4.
3. This Ordinance shall become effective upon publication as required by law.

1. The provisions of this ordinance relate to preferential highways and stop signs on certain highways in Dubois County, Indiana.







3. Motor vehicles operated on Co. Rd. 600 North from Co. Rd. 500 West to Co. Rd. 550 West being a distance of approximately 0.51 miles, shall be restricted to a maximum speed of 45 miles per hour.
4. Each such public highway shall be posted for such maximum speed limit.
5. Violation of this Ordinance shall be punishable in that manner prescribed by Indiana Statute and by prior Ordinance pertaining to speed limits heretofore adopted by this Board of County Commissioners.




AN ORDINANCE OF THE BOARD OF COMMISSIONERS OF DUBOIS COUNTY, INDIANA, PROHIBITING POSSESSION OF FIREARMS ON CERTAIN COUNTY PROPERTY

BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF DUBOIS COUNTY, INDIANA, THAT:

Section 1. No person shall possess a firearm in or on any structure owned by or leased to Dubois County, Indiana, or on the real estate upon which said structure is located.

Section 2. This ordinance shall not be applicable to the following:




- a) A federal, state or local law enforcement officer;
- b) A person who has been employed by the Board of County Commissioners as a security officer or who has been authorized by the Board of Commissioners of Dubois County or by a Judge of the Dubois Circuit or Superior Court to possess a firearm;
- c) The Dubois County Highway Department facility or the Dubois County 4-H Fair Grounds.
- d) Firearms taken to the public reception area of the County Security Center for processing purposes only.

Section 3. Any person in violation of this Ordinance shall be subject to enforcement by the Board of Commissioners of Dubois County, Indiana, which shall be authorized to impose as penalty a fine not to exceed Two Thousand Five Hundred Dollars (\$2,500.00); provided, that nothing herein shall prevent prosecution of said violation in any Court of record.



AN ORDINANCE VACATING A PUBLIC UTILITY AND DRAINAGE EASEMENT

An ordinance vacating a portion of a platted utility and drainage easement running between Lots No. 11, 12 and 13 in Sunrise Acres, Section 2, a subdivision in Bainbridge Township, Dubois County, Indiana.

**Section 1.**

AN ORDINANCE AMENDING ALL ORDINANCES  
AMENDATORY THEREOF, BEING AN ORDINANCE




WHEREAS, the Board of Commissioners now find that it is in the best interests of the citizens of said County to establish rules and regulations for the operation of vehicles in the use of the streets and highways hereinafter designated.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF  
COMMISSIONERS OF THE COUNTY OF DUBOIS, STATE OF INDIANA:


1. The provisions of this ordinance relate to preferential highways and stop signs on certain highways in Dubois County, Indiana.
2. County Road 500 West shall be the preferential highway where it intersects with County Road 1150 South and a stop sign shall be placed on the East and West approaches of said road County Road 1150 South with County Road 500 West.
3. Violation of this ordinance shall be punishable in that manner prescribed by Indiana statute and by prior Ordinance pertaining to preferential roads heretofore adopted by this Board of County Commissioners.
4. This Ordinance shall be effective from and following its passage and proper signing of the described intersection.

ORDINANCE NO. 2001-07

AN ORDINANCE OF THE BOARD OF COUNTY COMMISSIONERS OF DUBOIS COUNTY, INDIANA, VACATING A PUBLIC ALLEY BETWEEN CHARLES STREET AND SEITY STREET, IN HARBISON TOWNSHIP, DUBOIS COUNTY INDIANA

BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF DUBOIS COUNTY, INDIANA, THAT:

Section 1. It is the finding of this Commission, after public hearing, that adequate reason exists for the vacation of the platted alley located between Lots 103, 104 and 105 in the Seitz and Hartsfeld Addition in Harbison Township, of Dubois County, Indiana.

That proper notice has been given of said hearing; that the subject alley is not to be used by the public for an extended time and no public benefit is to be derived from the continued existence of said public alley; that the two (2) adjacent property owners have petitioned or consented to the vacation of said alley; that the vacation of said alley will not diminish the value of any other real estate located in the vicinity thereof; that public utilities known to exist within said easement shall remain in place; and that no reason exists of the continued existence of said alley and the same should now be vacated.

Section 2. That said public alley as herein described shall be and is hereby vacated, subject however to a continuing perpetual easement as to all public utilities which are now located within the boundaries thereof.

Section 3. That legal title in and to said real estate shall be and is hereby divided equally between and vested in the


adjacent property owners, to-wit: George O. Opel, Jr. and Donna S. Opel, and Irvin Skaggs.

ORDINANCE #01-8

AN ORDINANCE AMENDING THE DUBOIS COUNTY EMPLOYEE POLICY  
TO CHANGE PAY PERIODS FOR EMPLOYEE COMPENSATION

WHEREAS, Section III (M) of the Dubois County Employee Policy, as amended by Ordinance #99-12, has heretofore established that employee compensation would be issued annually in 24 payments on the 15th and 30th day of each month; and,

WHEREAS, The State Board of Accounts has objected to payment of compensation on the same date as the last day of each pay period; and,

WHEREAS, It is the determination of the Board of County Commissioners that the County may best satisfy its obligation to both Indiana statute and its employees by adopting a pay schedule which follows the last day of each pay period;

NOW, THEREFORE, BE IT ORDAINED, that the Pay Periods provision, as contained in Section III (M) of the Dubois County Employee Policy Handbook shall be amended to provide for two payments of employee compensation per month, on the second workday following the end of each pay period, and shall be amended to hereafter read as follows:

"M. PAY PERIODS

All supervisors are required to accurately record all hours worked by employees on their time record each week. Your net pay (after deductions for State and Federal Income Taxes, Social Security Tax, and any deductions authorized by you) will be issued annually in 24 payments, normally on the second workday following the 15th and 30th days of each month; provided, however that in any month having fewer than 30 days then on the second workday following the last day of said month; and provided further that the net pay for the last work day of December of each year shall be paid on said last workday of December. You will receive a record of your gross pay, deductions and net pay each pay period. Any problem regarding your pay should be directed to your supervisor.

Discrepancies will be corrected and any adjustment will

be reflected on the next regular payday. "Workday" shall be defined as being a day when the Dubois County Courthouse is open for regular business."

The foregoing policy and amendment to the Employee Handbook shall become effective on January 1, 2002.

ORDINANCE NO. 01-9

AN ORDINANCE OF THE BOARD OF COUNTY COMMISSIONERS OF DUBOIS COUNTY, INDIANA, VACATING A PORTION OF MAPLE STREET IN THE TOWN OF KYANA, JACKSON TOWNSHIP, DUBOIS COUNTY INDIANA

BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF DUBOIS COUNTY, INDIANA, THAT:

Section 1. It is the finding of this Commission, after public hearing, that adequate reason exists for the vacation of the following portion of Maple Street, County Highway located in the Town of Kyana, Jackson Township, of Dubois County, Indiana, to-wit:

All that portion of Maple Street south of the Norfolk - Southern Railway and north of Ohio Street, all in the Town of Kyana, in Section 31, Township 2 South, Range 3 West, in Jackson Township of Dubois County, Indiana.

That proper notice has been given of said hearing; that because of the construction of new roadway, no public benefit is to be derived from the continued existence of the above described public roadway; that the sole adjacent property owner has no objection to the vacation of said highway; that the vacation of said highway will not diminish the value of any other real estate located in the vicinity thereof; that public utilities which exist within said easement shall remain in place; and that no reason exists of the continued existence of said highway and the same should now be vacated.


Section 2. That said public highway as herein above described shall be and is hereby vacated, subject however to a continuing perpetual easement as to all public utilities which are now located within the boundaries thereof.


Section 3. That legal title in and to said real estate shall be and is hereby vested in the adjacent property owner, to-wit: Wallhauser Farms, Inc.
