A RESOLUTION MAKING AVAILABLE AND COMMITTING FUNDS BY THE
DUBOIS COUNTY COMMISSIONERS AS PART OF THE LOCAL NON-FEDERAL
MATCH FOR ECONOMIC DEVELOPMENT ADMINISTRATION GRANT
ASSISTANCE

WHEREAS, the Dubois County Commissioners in cooperation the Town of Ferdinand has developed a proposed street construction project, involving the improvement of existing town roads and the construction of a new road connecting Old Huntingburg Road with 3rd Street to provide access to the growing industrial area west of Ferdinand.

WHEREAS, the Economic Development Administration, U.S. Department of Commerce, has invited the Town of Ferdinand to submit an application for a federal grant for the partial funding of the above described project, which for identification purposes has been assigned SAI# IN 900209 090 by the Indiana State Budget Agency; and,

WHEREAS, EDA's Public Works Improvement Program application requires a written commitment from the local government entities to guarantee the availability and obligation of necessary local matching funds to assure that sufficient funds are available for the total project costs; and

NOW THEREFORE, BE IT RESOLVED by the County Commissioners of Dubois County, Indiana, that:

1. As an inducement for the Economic Development Administration, United States Department of Commerce to act favorably upon the Application for Grant Assistance for the above-mentioned project, Dubois County does hereby agree to set aside and commit a sum not to exceed \$80,000 from its Highway Fund and a sum estimated at \$67,941 but not to exceed \$80,000 from its Cumulative Bridge Fund revenues to be applied to the cost of the above-referenced project as and for Dubois County's local share of the cost of said project.
2. The Commissioners of Dubois County further resolve to take such action as may be necessary to appropriate and obligate said funds as they become available for the above-mentioned project, but in any event said funds shall be appropriated as part of the regular budget proceedings for establishing the budget and appropriations for the calender year 1990 for the County of Dubois, Indiana.

Before commencement of construction of any business building or private residence where a private sewage disposal system or privy is to be installed or where any alteration, repair or addition of an existing private sewage disposal system is planned, the owner or agent of the owner shall first obtain a written permit signed by the Health Officer. The application for such permit shall be made on a form provided by the Dubois County Health Department which application shall be supplemented by any plans, specifications and other information as is deemed necessary by the Health Officer. The application for a permit shall be accompanied by an acceptable plot plan, showing dimensions of the lot and the distances from the sewage disposal system to the dwelling and other pertinent buildings. The plot plan shall show the following:
1. Location of proposed sewage disposal system or changes to existing one.
 2. Location of any existing or proposed source of water supply and water lines on property.
 3. Location of water supply sources, water service lines, and sewage disposal systems within 100 feet.
 4. Completed soil survey evaluation, conducted by a soil scientist, containing any information the soil scientist feel is pertinent to the site.
- B. No person shall construct, install, connect, alter or extend a private sewage disposal system within Dubois County, Indiana without first having filed a written application as set forth in this ordinance and having a written permit from the Health Officer.
- C. A fee of twenty (\$20.00) dollars shall be paid with each application for permit filed with the Dubois County Health Department.
- D. A separate permit shall be obtained for sewage disposal work on each dwelling.
- E. If the sewage disposal system has not been constructed, installed, altered, or extended within one year from the date of issuance, the permit shall automatically expire.
- F. The Health Officer shall deny a permit if the information on the application is incomplete, inaccurate, or indicates that the provisions of this ordinance cannot be met.
- G. The issuance of a permit does not constitute assumption by the Dubois County Health Department or its employees of liability for the failure of any sewage disposal system.
- H. The Health Officer shall maintain a register of all persons engaged in or intending to engage in the installation of sewage disposal devices or equipment within Dubois County, Indiana.
- I. Any individual, firm, association, or corporation engaged in or intending to engage in the installation of sewage disposal devices or equipment shall make application to the Health Officer to have his name placed on the register for those engaged in the installation of sewage disposal devices or equipment. The applicant shall submit an application fee of twenty-five (\$25.00) dollars per calendar year or part thereof. The application form shall contain the name and address of the person making

application and the address of the firm or place of business he is associated with, and such information as the Health Officer determines will reasonably aid in the administration and enforcement of this ordinance.

- J. Upon acceptance of prospective applicant's registration, registrant shall post a surety bond with the Board of Health, Dubois County, State of Indiana, in the penal sum of not less than one thousand (\$1,000.00) dollars in favor of the Board of Health conditioned upon registrant's faithful compliance with the rules and regulations which may from time to time be established by the Board of Health, Dubois County, State of Indiana, relating to the installation of sewage disposal devices or equipment.
 - K. Upon recommendation to the Health Officer, the Board may remove the name of any individual, partnership, firm, association, or corporation from the register of persons engaged in the installation of sewage disposal devices or equipment who have demonstrated inability or unwillingness to comply with the regulations. Such person may have his name reinstated on the register of persons engaged in the installation of sewage disposal devices or equipment by the Board of Health after satisfactory demonstration of ability or willingness to comply with the regulations.
 - L. All fees collected under the terms of this ordinance shall be receipted weekly into the Dubois County Treasury and credited to the Dubois County Health Fund for services rendered in enforcing this ordinance.
 - M. The permit for a private sewage disposal system shall be posted by the permittee in a conspicuous place at or near the building where the sewage disposal system is under construction. The notice should be plainly visible from the public thoroughfare serving the building.
 - N. The provisions of the permit for the construction of a private sewage disposal system or privy shall not be considered fulfilled until the installation is completed to the satisfaction of the Health Officer or his agent. The permittee shall notify the Health Officer at least one (1) working day prior to completion of the system for final backfill inspection. Such final inspection is required before any underground portions are covered.
 - O. The Health Officer or his agent shall be permitted to enter upon all properties at the proper time for purposes of inspection, observation, and testing necessary to carry out the provisions of this ordinance.

SECTION . ENFORCEMENT PROCEDURE

- A. Any person found to be violating any provision of this regulation may be served by the Health Officer with a written order stating the nature of the violation and providing a time limit for satisfactory correction thereof.
- B. After receiving an order in writing from the Health Officer, the owner, agent of the owner, the occupant or agent of the occupant of the property shall comply with the provisions of this ordinance as set forth in said order and within the time limit included therein. Said order shall be served on the owner or agent of the owner and the occupant or the agent of the occupant, but may be served on any person who, by contact with the owner, has assumed the duty of complying with the provisions of an order.

SECTION . PENALTIES

Any person found to be violating any provision of this ordinance shall be guilty of a misdemeanor. On conviction, the violator shall be punished for the first offense by a fine of not more than five hundred (\$500.00) dollars; for the second offense by a fine of not more than one thousand (\$1,000.00) dollars; and for the third and each subsequent offense by a fine of not more than one thousand (\$1,000.00) dollars to which may be added imprisonment for any determined period not exceeding ninety (90) days, and each day after the expiration of the time limit for abating insanitary conditions and conditions as ordered by the Health Officer or his agent, shall constitute a distinct and separate offense.

SECTION . APPEALS PROCEDURES

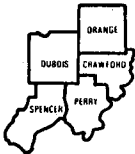
- A. Of an applicant is refused a permit, the administrative authority shall, upon request, afford the applicant a fair hearing in accordance with provisions of IC 4-22-1.
- B. The administrative authority may, after reasonable notice and opportunity for fair hearing, in accordance with the provisions of IC 4-22-1, revoke a permit for authorizing the construction of a private sewage disposal system if it finds that the holder of the permit has failed to comply with any provision of this ordinance.

SECTION . VALIDITY

If any section, paragraph, sentence, clause, phrase, or word of this ordinance, or any part thereof be declared invalid for any reason, the remainder of said ordinance shall not be affected thereby and shall remain in full force and effect.

SECTION . DATE OF EFFECT

This ordinance shall be in full force and effect on the _____ of _____, 1991, upon its adoption and its publication as provided by law.

A RESOLUTION AUTHORIZING THE PURCHASE OF PROPERTY FROM THE MARION COUNTY BUILDING AUTHORITY

WHEREAS, the Indianapolis-Marion County Building Authority ("Building Authority") is a "disposing agent" for property under Indiana Code 36-1-11-2;

WHEREAS, the Building Authority currently possesses a number of binder shelves formerly used to store registration information for the Marion County Board of Voter Registration;

WHEREAS, the Building Authority and Marion County Board of Voter Registration have determined that it is no longer necessary or desirable for the binder shelving formerly used by Voter Registration to be retained;

WHEREAS, Indiana Code 36-1-11-8 permits the transfer or exchange of property between governmental entities under terms and conditions agreed upon by the entities as evidenced by the adoption of a substantially identical resolution by each entity; and

WHEREAS, the Dubois County Election Board has need for the type of shelving which the Building Authority desires to dispose of and desires to acquire said shelving; and

WHEREAS, the Dubois County Election Board has made an offer to purchase from the Building Authority several binder shelves for an amount of cash;

NOW, THEREFORE, be it resolved that Dubois County, Indiana, shall purchase Twenty-one (21) sections of binder shelving in accordance with Indiana Code 36-1-11-8, from the Building Authority.

RESOLVED, FURTHER, that the Dubois County Election Board agrees to pay the Building Authority the sum of Twenty-One Dollars (\$21) for such property.

RESOLVED, FURTHER, that the Building Authority shall make the described property available to Dubois County Election Board immediately upon receipt of payment and the Dubois County Election Board shall remove the property at its expense from the custody of the Building Authority within thirty (30) days following the date of payment.
