COMPLAINT NO. 1

At this time, we, the owners of the sub-division, are requesting a full refund for all out of pocket expenses to widen the road (approx. 1200') to County specifications. We are not requesting a refund for manual labor to clear the roadway and dispose of all the brush and trees, or for the loss of income on the funds used to finance the project. The land, as in the case of Mr. Albert Hoffman, has been donated by Mr. Linus Eckert.

Reason: We, the owners, believe the County (County Officials) were fully aware that the roadway located in front of Mr. Hoffman's property was to be widened, and was already in the planning stages the same time we the owners were debating the road requirements. And, that the same County Officials deliberately withheld this information. And, deliberately let us spend our private dollar to widen the road, when, in fact it should have been public funds.

CONTRACT FOR SERVICES

THIS AGREEMENT, made and entered into as of the 7th day of January, 1991, by and between the County of Dubois, Indiana (hereinafter referred to as the "County", which term shall be construed to include any officer, or Council of the County having authority to represent or act for it, in relation to any part of the subject of this contract), and the Indiana 15 Regional Planning Indiana with offices located at 511 Fourth Street, in Huntingburg, IN 47542 (hereinafter referred to as the "Commission"),

SCOPE OF SERVICES

The Commission through its staff shall provide direct assistance to the County, including their authorized staff representatives, and others in the updating of the Dubois County Road Map. The Map updating will include the following elements:

- o The Commission will provide Dubois County with an up-to-date County Road Map.
- o The maps will be in color over a black base.
- o The Commission will retain the inked mylars. The Commission will be responsible for taking the color overlays to the printer and work with the printer to the County's satisfaction. The County is responsible for printing costs. The \$11,300 contract amount does not include printing costs.
- o The size will be 28" x 30" at a scale of 1"= 1 mile.
- o The unincorporated Towns in Dubois County will be inked on the back of the County Map in black and white.
- o A separate subdivision map in black and white will be prepared showing subdivisions and plats in Dubois County outside of the incorporated cities and towns.
- o The information will be field checked by Indiana 15 Regional Planning Commission with assistance from the Dubois County Highway Department.

The preparation will be coordinated with the works of pertinent officials of the County. (It is understood that Indiana 15 Regional Planning Commission does not provide professional legal or engineering services.)

COMPENSATION TO COMMISSION

The County shall compensate the Commission for the above-mentioned update of County Maps in an lump sum not to exceed \$11,300.00.

DATE OF CONTRACT TO BEGIN

This contract shall commence and become effective as of January 7, 1991 and costs incurred thereafter and before termination shall be eligible for reimbursement provided the other conditions of this contract are met.

DATE OF TERMINATION OF CONTRACT

This contract shall be completed on or before March 31, 1991.

This Agreement between Dubois County, Indiana, by its Board of County Commissioners ("County") and Mehling Engineering & Surveying, Inc. of Ferdinand, Indiana ("Mehling").

Dubois County, Indiana does hereby engage the services of Mehling Engineering & Surveying, Inc. to provide assistance to the Dubois County Communications Officer in the completion of the Road and Structure Numbering Project for Dubois County, Indiana and to correct errors and inaccuracies in that portion of said Project completed to this date. In performing this service, Mehling agrees to and shall act under the direction of said County Communications Officer.

As compensation for services provided by Mehling under this Agreement, County shall pay Mehling at the rate of Thirty Dollars (\$30.00) per hour for each and every hour of such service, but in no event to exceed a total sum of Ten Thousand Dollars (\$10,000.00).

CONTRACT FOR SERVICES

THIS AGREEMENT, made and entered into as of the 14 day of February, 1991, by and between the County of Dubois, Indiana (hereinafter referred to as the "Grantee", which term shall be construed to include any officer, representative or council of the Grantee having authority to represent or act for it, in relation to any part of the subject of this contract), and the Indiana 15 Regional Planning Commission, with offices located at 511 Fourth Street, in the City of Huntingburg, Dubois County, Indiana (hereinafter referred to as the "Commission"), witnesseth:

WHEREAS, the Grantee has received a Community Focus Fund Grant from the Indiana Department of Commerce in an amount of \$174,300.00 (Project No. CF-90-316) to construct a new fire station for the unincorporated Community of Schnellville, as outlined in the Grantee's application for said grant, and

WHEREAS, the aforementioned Community Focus Fund grant includes funds budgeted to cover environmental review assessments costs required to implement the program, and

WHEREAS, the Grantee desires to contract with the Commission for staff technical and environmental services in connection with the project, and for related assistance during the progress of the project, all is hereinafter stipulated.

NOW, THEREFORE, the Grantee and the Commission in consideration of the mutual covenants and the conditions and agreements herein contained agree as follows:

SECTION 1. Not-for Profit Status of Commission. The Commission, through its staff, shall provide the aforementioned professional services for the project in the manner of a not-for-profit independent contractor and professional consultant in its relationship with the Grantee and in accordance with the terms and conditions of this Contract.

SECTION 2. Compensation to Commission. The Grantee shall compensate the Commission in accordance with the terms and conditions of this Contract for the Commission's services as outlined in Exhibit A. In no event shall the compensation to the Commission for services rendered pursuant to this Agreement exceed the lump sum of \$6,000.00 provided the aforementioned project is completed on or before the expiration date specified in Section 15.

SECTION 3. Payment to the Commission. Payment for services rendered (as described in Exhibit A) shall be made pursuant to the submission of claim forms, accompanied by statement setting forth the nature of services and the hours required for each project by the Commission, and the same shall be paid in accordance with the usual and regular fiscal procedures of the State of Indiana.

SECTION 4. The Grantee's Responsibility. The Grantee shall provide full information and provide access to the Grantee's records needed to carry out the project.

SECTION 5. Designation of Grantee Representatives. The Grantee may designate, when necessary, a representative authorized to act on its behalf. The Grantee, through its representatives, shall examine documents and technical materials prepared and submitted by the Commission and shall cooperate with the Commission staff representatives to avoid undue delays in the performance of the project requirements.

SECTION 6. Place of Performance. The Commission shall perform and furnish services at its Huntingburg, Indiana offices, or at such place or places as may be authorized from time to time by the Grantee.

SECTION 7. Termination. The Grantee may at any time, and for any reason, terminate this Contract by written notice to the Commission specifying the termination date, which shall be not less than seven (7) days from the date such notice is delivered to the Commission. In the event of such termination, the Commission shall be paid such amount as shall compensate it for the portion of the work satisfactorily performed prior to the termination date. Such amount shall be fixed by the Grantee after consultation with the Commission, and shall be subject to audit by the Grantee's fiscal officer. Termination under this section shall not give rise to any claim against the Grantee or the Commission for damages or for compensation in addition to that provided hereunder.

SECTION 8. Amendments. This Contract may be amended or supplemented in any particular section by following the procedures used for its adoption.

SECTION 9. Conflict of Interest. The Commission covenants that it presently has no interest and shall not acquire any interest direct or indirect, which would conflict in any manner or degree with the performance of services required to be performed under this Contract, and that the Commission will not knowingly permit any employee or agents with any such interest to take part in the services rendered under this contract.

SECTION 10. Assignment. The parties each hereby bind themselves, their successors, assigns and legal representative to each other with respect to the terms of this Contract. Neither party shall assign, sublet or transfer any interest in this Contract without written authorization of the other.

SECTION 11. Compliance with Laws, Ordinances, Etc. The Commission, its agents and employees, and authorized subcontractors shall comply with all applicable federal and state laws, ordinances of the Grantee, and with all applicable rules and regulations promulgated by all local, state and federal boards, bureaus, and agencies. (Exhibit B)

SECTION 12. Availability of Funds. The Grantee shall pay for any and all services of the Commission, as provided in the conditions set forth in other Sections of this Contract. The Grantee does not promise to pay the Commission for services out of any other of the Grantee's funds.

SECTION 13. Cooperation with the Grantee's Designated Agencies. The Commission agrees to assist any or all of the Grantee's personnel or agencies, designated by the Grantee by contract or resolution or other written document, to assume or share responsibility regarding the implementation of the Contract, and such designated personnel and agencies shall provide information and cooperation to the Commission to the extent provided in the Contract and other contracts, resolutions, or written agreements.

SECTION 14. Date Contract to Begin. This Contract shall commence and become effective as of the _____ day of _____, 199____ and costs incurred thereafter and before termination shall be eligible for reimbursement provided the conditions of this Contract are met.

RESOLUTION

WHEREAS, the Indiana Legislature, by I.C. 5-2-11-1 et. seq. has established a county drug free community fund for Dubois County to promote comprehensive local alcohol and drug abuse prevention initiatives; and

WHEREAS, the Local Coordinating Committee, Dubois County Substance Abuse Task Force, has been organized to develop on an annual basis a comprehensive plan to promote comprehensive local alcohol and drug abuse prevention initiatives and has adopted such a plan for the 1990-91 fiscal year ending June 30, 1991; and

NOW, THEREFORE, the Dubois County Council does resolve as follows:
