I have been requested to advise you of the jurisdiction of Dubois County.

I.C. 36-1-39 provides as follows: (a) The area inside the boundaries of a county comprise its territorial jurisdiction. However, a municipality has exclusive jurisdiction over bridges, streets, alleys, sidewalks, watercourses, sewers, drains and public grounds inside its corporate boundaries, unless a statute provides otherwise.

I.C. 36-1-7-9 provides that a county and municipality may jointly construct and maintain highway under interlocal agreements. I.C. 36-1-7-11 provides that both may appropriate funds and provide personnel, services and facilities.

Pursuant to the above the County has jurisdiction over the highways in the County and a city and county can agree to jointly construct and maintain streetsand highways inside and outside the corporate limits of a city.

WHEREAS, the County of Dubois and the City of Huntingburg have jointly developed a proposed road construction project involving the improvements of existing county roads and the construction of new roads along the western boundary of the City of Huntingburg to provide access to industries in such area creating an industrial access road between State Road 64 West and U.S. Highway 231 North and commonly known as the "Huntingburg Industrial Access Road Project"; and

WHEREAS, on September 30, 1988, the Economic Development Administration, U.S. Department of Commerce awarded a grant to the County of Dubois and the City of Huntingburg, jointly, to be applied to the costs of said project, which grant is the lesser of \$725,227.00 or 54.94% of the actual cost of said project; and

WHEREAS, the City of Huntingburg has been awarded a Community Development Block Grant by the Indiana Department of Commerce in the sum of \$334,233.00 for application to the costs of said road project; and

WHEREAS, the County of Dubois and the City of Huntingburg are desirous of designating a lead agency for the administration of such project and providing for the payment of the costs of said project which are not covered by said grants;

NOW, THEREFORE, BE IT RESOLVED by the County Council of Dubois County, Indiana that the County of Dubois enter into an Intergovernmental Cooperation Agreement with the City of Huntingburg whereby the County of Dubois agrees to pay 50% of the costs of said Huntingburg Industrial Access Road Project in excess of the amount of the grants aforementioned; provided, however, that the County's share of said project shall not exceed the sum of \$130,000.00.

BE IT FURTHER RESOLVED that the City of Huntingburg be designated as the lead agency for the administration of the
