LANDFILL USE AGREEMENT

This Agreement made and entered into this 22nd day of December, 1988, by and between the CITY OF JASPER, a municipal corporation of the State of Indiana, hereinafter sometimes referred to as the "City"; and, the BOARD OF COMMISSIONERS OF DUBOIS COUNTY, INDIANA, hereinafter sometimes called "County";

WITNESSETH:

WHEREAS, the County presently uses the City sanitary landfill for the disposal of trash collected by the County pursuant to a contract dated July 10, 1987, and which said contract expires at 12:00 a.m. (midnight) December 31, 1988; and,

WHEREAS, the County desires to continue use of the City sanitary landfill during the year 1989 and while it pursues its intention of securing and putting into operation a County owned landfill to serve all areas of Dubois County, including the City of Jasper.

NOW, THEREFORE, in consideration of the sum of One Dollar (\$1.00), the receipt of which is herewith acknowledged, the rental payments and escrow payments to be made by the County to the City, and other good and valuable consideration, the parties do agree as follows:

- (1) That the County may, by its own vehicles only, empty its trash collections at the City sanitary landfill during regular landfill hours.
- (2) This Agreement shall be for a term of one (1) year, commencing at 12:01 a.m. January 1, 1989, and expiring at 12:00 a.m. (midnight) December 31, 1989.
- (3) That as a fee for the use of the said City sanitary landfill the County agrees to pay to the City the

sum of One Hundred Twenty Thousand Dollars (\$120,000.00), said sum to be paid in twelve (12) equal monthly installments of Ten Thousand Dollars (\$10,000.00) each, with each installment to be paid on or before the 15th day of each month during the lease term commencing with January 15, 1989.

(4) The County further agrees to pay to the City the sum of Sixty Thousand Dollars (\$60,000.00) for the purpose of defraying the ordinary and continuous expenses that will be incurred by the City in the closing, maintaining and monitoring of the City Sanitary Landfill at such time as it is physically closed and ceases operation. Said sum shall be paid in twelve (12) equal monthly installments of Five Thousand dollars (\$5,000.00) each; with each installment to be paid on or before the 15th day of each month during the lease term, commencing with January 15, 1989.

The City agrees that said sum of Sixty Thousand Dollars (\$60,000.00, as it is received, shall be deposited in an "Escrow" account to be used solely for the purposes set forth in this paragraph.

The parties hereto agree that the closing down date of the sanitary landfill has not yet been determined; and that the time required after the closing before the "close-down" is fully completed will take several years and will be done in accordance with the prevailing statutes of the State of Indiana.

The parties further agree for their existing council members, commission members and their successors in office, that upon the total and permanent close-down of the sanitary landfill and upon receipt of a certification to that effect from the State of Indiana, that any funds remaining in the "Escrow" account and attributable to contributions made

by the County pursuant to this Agreement, shall be returned to the County for use in its own landfill project.

- (5) As a further consideration for this Agreement, the County agrees to deligently pursue the obtaining and opening of a Dubois County Sanitary Landfill site during 1989.
- The parties agree that this Agreement, upon its expiration, may be extended for additional one (1) month periods upon the same terms and conditions, only upon a written agreement executed by both parties hereto.

RESOLUTION OF THE COMMISSIONERS OF DUBOIS COUNTY, INDIANA, AUTHORIZING THE SUBMITTAL OF THE CFF APPLICATION TO THE INDIANA DEPARTMENT OF COMMERCE AND ADDRESSING RELATED MATTERS

WHEREAS, the Dubois County Commissioners, Indiana recognize the need to stimulate growth and to maintain a sound economy within its corporate limits; and

WHEREAS, The Housing and Community Development Act of 1974, as amended, authorizes the Indiana Department of Commerce to provide grants to local units of government to meet the housing and community development needs of low and moderate income persons; and

WHEREAS, the Dubois County Commissioners propose to apply for federal assistance under the Housing and Community Development Act of 1974, as amended, fiscal year 1993 program, administered by the Indiana Department of Commerce and referred to as the Community Focus Fund (CFF); and

WHEREAS, the Dubois County Commissioners, Indiana have conducted public hearings prior to the submission of an application to the Indiana Department of Commerce, said public hearings to assess the housing, public facilities and economic needs of its low and moderate income residents;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSIONERS OF DUBOIS COUNTY, INDIANA THAT:

- 1. A final application for the transmission of water from Patoka Lake Regional Water and Sewer District to connect ten water utilities including the Haysville Water Utility be prepared and submitted to the Department of Commerce, State of Indiana.
- 2. The President of the Dubois County Commissioners be authorized to sign said application or applications.
- 3. If such application shall be approved in whole or in part, the President of the Dubois County Commissioners shall be authorized to operate the grant program, to carry such program to completion, and to sign such contracts, interlocal agreements, and other documents as may be necessary to accomplish them.
- 4. Contingent upon the receipt of any such grant funds the party to commit the match shall be Patoka Lake Regional Water and Sewer District, through a FmHA loan in the amount of at least \$51,000.
- 5. This resolution shall become effective immediately.

A RESOLUTION OF THE COUNTY COUNCIL OF DUBOIS COUNTY, INDIANA, PROPOSING AND SUPPORTING RESCISSION OF THE COUNTY ECONOMIC DEVELOPMENT INCOME TAX IN DUBOIS COUNTY, INDIANA.

WHEREAS, This County Council did, by Ordinance #1988-1, propose, submit and vote in favor of imposing in Dubois County a County Economic Development Income Tax ("EDIT"); and,

WHEREAS, It was the intent of this Council in submitting this tax to provide a means of financing the construction of the Dubois County Security Center; and,

WHEREAS, Funds subsequently provided from said tax and from other sources will have fully paid the cost of construction of said Security Center in January, 1994; and,

WHEREAS, It was the commitment of this Council to the taxpayers of this County that upon full payment of costs related to the construction and equipping of said Security Center, that this Council would initiate the termination of such County Economic Development Tax.

NOW THEREFORE, BE IT RESOLVED by the County Council of Dubois County, Indiana, that it does hereby recognize its commitment to the taxpayers of Dubois County to terminate the County Economic Development Income Tax, and does hereby direct and instruct the Auditor of Dubois County to prepare or have prepared a proper proposed Ordinance to be submitted to this Council at its first meeting after January 1, 1994 (being the first date on which the County Income Tax Council may legally act thereon), which Ordinance proposes and casts the votes of this Council in favor of the rescission of the Dubois County Economic Development Income Tax, effective July 1, 1994.
