ORDINANCE AUTHORIZING THE CITY OF JASPER TO

WHEREAS, the Jasper Economic Development Commission has rendered its Project Report for the Wabash Valley Produce, Inc. Project regarding the financing of proposed economic development facilities for Wabash Valley Produce, Inc.; and

WHEREAS, the Jasper Economic Development Commission conducted a public hearing on May 17, 1995, and also adopted a Resolution on May 17, 1995, which Resolution has been transmitted hereto, finding that the financing of certain economic development facilities of Wabash Valley Produce, Inc., complies with the purposes and provisions of I.C. 36-7-11.9 and 12; may have an adverse competitive effect on similar facilities now operating near Dubois County; and that such financing will be of benefit to the health and welfare of the County of Dubois and its citizens; and

WHEREAS, the Jasper Economic Development Commission has heretofore approved and recommended the adoption of this form of ordinance by this Common Council and has approved the substantially final forms of and transmitted for approval by this Common Council the Loan Agreement, Note, Trust Indenture, Bond Placement Agreement and Letter of Representations; now therefore,

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF JASPER, INDIANA, THAT:

Section 1. It is hereby found that the financing of the economic development facilities which comprises the acquisition of land and the construction and equipping of an egg production and processing facility located at 7879 North Hickory Grove Road, Dubois, Indiana, referred to in the Loan Agreement and Trust Indenture approved by the Jasper Economic Development Commission and presented to this Common Council; the issuance and sale of revenue bonds pursuant to the Trust Indenture; the loan of the proceeds of the revenue bonds to Wabash Valley Produce, Inc.; and the payment of the revenue bonds by the Project Note payments of Wabash Valley Produce, Inc. under the Loan Agreement complies with the purposes and provisions of I.C. 36-7-11.9 and 12; and will be of benefit to the health and welfare of the County of Dubois and its citizens.

Section 2. The substantially final forms of the Loan Section 2. The substantially final forms of the Loan Agreement, Note, Trust Indenture, the Bond Placement Agreement among the City of Jasper, Indiana, Wabash Valley Produce, Inc. the Bond Placement Agreement and Bank One, Columbus, NA (the "Purchaser"), (the "Bond Placement Agreement") and the Letter of Representations with The Depository Trust Company as defined in the Trust Indenture approved by the Jasper Economic Development Commission are hereby approved (herein collectively referred to as the "Financing Agreement" referred to in I.C. 36-7-12), and all such documents shall be incorporated herein by reference and shall be inserted in the minutes of the Common Council and kept on file by the Clerk-Treasurer. In accordance with the provisions of I.C. 36-1-5-4, two (2) copies of all such documents are on file in the office of the Clerk-Treasurer for public inspection.

The City of Jasper shall issue its Economic Development Adjustable Rate Revenue Bonds, Series 1995 (Wabash Valley Produce, Inc. Project), in the principal amount not exceeding \$2,000,000 and maturing not later than 15 years from the date of the first principal payment, which in no event may exceed thirty (30) years, for the purpose of procuring funds to pay the costs of acquisition of the land and construction and equipping of the economic development facilities as more particularly set out in the Loan Agreement incorporated herein by reference, which bonds will be payable as to principal, premium, if any, and interest from the payments made by Wabash Valley Produce, Inc. under the Loan Agreement or as otherwise provided in the above described Loan Agreement, Note, and Trust Indenture. The bonds shall be issued in registered form, shall be issued in the denominations of \$100,000 and any integral multiple of \$5,000 in excess thereof, and shall be redeemed as provided in Article IV of the Trust Indenture. Payments of principal and interest are payable in lawful money of the United States of America at the principal office of PNC Bank, Indiana, Inc., as Trustee or by check or draft mailed or delivered to the registered owner as provided in the Trust Indenture. The bonds shall never constitute a general obligation of, an indebtedness of, or a charge against the general credit of the City of Jasper, nor are the bonds payable in any manner from revenues raised by taxation.

The Mayor and Clerk-Treasurer are authorized and Section 4. directed to execute and deliver the bonds to the Trustee for appropriate authentication, and the Trustee may deliver such bonds on the direction of the Purchaser upon receipt of a purchase price not less than 100% of the principal amount thereof, and at an interest rate on the bonds not to exceed 10%. The City of Jasper authorizes the distribution and use of the Preliminary Offering Memorandum and the Offering Memorandum in connection with the sale of the bonds. 443

The Mayor and Clerk-Treasurer are authorized and Section 5. directed to execute, attest, affix or imprint by any means the City seal to the documents constituting the Financing Agreement approved herein on behalf of the City and any other document which may be necessary or desirable to consummate the transaction, including the bonds authorized herein. and Clerk-Treasurer are hereby expressly authorized to approve any modifications or additions to the documents constituting the Financing Agreement which take place after the date of this Ordinance with the review and advise of the City Attorney; it being the express understanding of this Common Council that said Financing Agreement is in substantially final form as of the date The approval of said modifications or of this Ordinance. additions shall be conclusively evidenced by the execution and attestation thereof and the affixing of the seal thereto or the imprinting of the seal thereon; provided, however, that no such modification or addition shall change the maximum principal amount of, interest rate on or term of the bonds as approved by the Common Council by this Ordinance without further consideration by the Common Council. The signatures of the May The signatures of the Mayor and Clerk-Treasurer on the bonds may be either manual or facsimile signatures. The Clerk-Treasurer is authorized to arrange for delivery of such bonds to the Trustee named in the Trust Indenture, and payment for the bonds will be made to the Trustee named in the Trust Indenture and after such payment, the bonds will be delivered by the Trustee to purchasers thereof. The Mayor and Clerk-Treasurer shall execute and the Clerk-Treasurer shall deliver the bonds to the Trustee within ninety days of the adoption of this ordinance. The bonds shall be dated the date of their delivery.

Section 6. The City of Jasper hereby elects pursuant to Section 144(a)(4)(A) of the Internal Revenue Code of 1986, as amended, to apply the \$10,000,000 test for outstanding bonds and capital expenditures, as embodied in that Section, to the City of Jasper, Indiana Economic Development Adjustable Rate Revenue Bonds, Series 1995 (Wabash Valley Produce, Inc. Project).

Section 7. The provisions of this Ordinance and the Trust Indenture securing the bonds shall constitute a contract binding between the City of Jasper and the holders of the Economic Development Adjustable Rate Revenue Bonds, Series 1995 (Wabash Valley Produce, Inc. Project), and after the issuance of said bonds, this Ordinance shall not be repealed or amended in any respect which would adversely affect the rights of such holders so long as any of said bonds or the interest thereon remains unpaid.

Section 8. This Ordinance shall be in full force and effect from and after its passage and signing by the Mayor.
